Regulations for safety

Last year we conducted more than 3,686 tests for more than 80 drinking water contaminants. We are proud to inform you that the City of Vienna did not have any violations of water quality parameters during 2010 with five regulated contaminants detected at low levels since 2003. This brochure is a snapshot of the quality of the water we provided last year. Included are details about where your water comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) standards. Special population advisory

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Drinking water sources

Your water comes from the Cretaceous and Claiborne aquifers located beneath the ground. The water is pumped from five ground water wells located throughout the City of Vienna. Contaminants in water

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Vienna is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking purposes. If you are concerned about lead in your water, you may wish to have your water tested. The sources of drinking water (both tap water and bottled water)

include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water before we treat it include:

- *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- *Inorganic contaminants*, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- *Pesticides & herbicides*, which may come from a variety of sources such as agriculture and residential use.
- *Radioactive contaminants*, which are naturally occurring.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and also can come from gas stations, urban stormwater runoff, and septic systems.

Water quality monitoring

To ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. We treat our water according to EPA's regulations. Food & Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Water quality data

Unless otherwise noted, data presented in the following table are test water analysis results from the 2010 calendar year. The presence of contaminants in the water does not necessarily indicate that the water poses a health risk.

The state requires community water systems (CWS) to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly year to year.

The Environmental Protection Division issued waivers to the City of Vienna to exempt our water system from monitoring synthetic organic contaminants (SOCs) and the following two inorganic contaminants (IOCs): Asbestos and Cyanide through December 31, 2013; demonstrating that the system's distributed drinking water complies with the chemical monitoring standards of the Georgia Rules for Safe Drinking Water. The Division has placed the City of Vienna on a triennial monitoring schedule for all remaining IOCs since studies indicate concentrations of these contaminants in our water system are low and no longer necessitate annual monitoring.

Based on an initial radiological monitoring event from October 2005 through June 2006, the division issued a schedule for our system to monitor following four parameters once every six years: Alpha, Radium-226, Radium-228, and Uranium. The initial monitoring event yielded detection for Radium-228 only. We are scheduled to perform radiological monitoring once from 2008 through 2013.

The Vienna CWS falls into schedule 4 (3,000 to 10,000 population served) under Stage 2 Initial Distribution System Evaluation (IDSE) for total trihalomethanes (TTHMs) and five haloacetic acids (HAA5) monitoring. The Stage 2 IDSE schedule 4 monitoring began July 16, 2009 and was sampled quarterly through April 14, 2010. Stage 1 TTHM/HAA5 monitoring remains in progress.

Terms & Abbreviations

- **AL:** Action Level - the concentration of a contaminant which, when exceeded, triggers treatment or other requirements that a water system must follow.
- **MCL:** Maximum Contaminant Level - the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- **MCLG:** Maximum Contaminant Level Goal - the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- **MRDL:** Maximum Residual Disinfection Level - the highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbiological contaminants.
- **MRDLG:** Maximum Residual Disinfection Level Goal - the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- **n/a:** not applicable
- **Nd:** not detectable at testing limit
- **NTU:** Nephelometric Turbidity Units
- **pCi/l:** picocuries per liter (a measure of radioactivity)
- **ppm:** parts per million or milligrams per liter -- (corresponds to one minute in two years)
- **ppb:** parts per billion or micrograms per liter --(corresponds to one minute in 2,000 years)
- **TT:** Treatment Technique - A required process intended to reduce the level of a contaminant in drinking water
